Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Para A of Part A of Schedule III to the said Regulations we wish to inform you that the company has received a notice issued under Section 46(4) of the Food Safety and Standards Act, 2006 (hereinafter, FSS Act) providing for opportunity to appeal against the report of the Food Analyst Report dated July 29, 2024 whereby the sample collected by the Food Safety Officer is declared as sub-standard under section 3(zx) of the FSS Act.
