### 2. Nature and details of the action(s) taken, initiated or order(s) passed

Reasons to be provided within 7 days from receipt of this notice showing cause why further legal action should not be initiated. Furthermore, since the offence is compoundable in nature in view of Section 48 of the Act, you can submit application for compounding within 7 days of receipt of the letter alongwith relevant documents and proofs under section 49 of the Act.

If no such application is filed, it would be assumed that you have no defense and further legal action will be taken.













3. Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority;

# 4. Details of the violation(s)/contravention(s) committed or alleged to be committed;

It has been alleged that the package of product- Daawat Dubar Basmati Rice- 1kg pack- was found without the USP(Unit Sale Price) as required by the rules.

Alleged violation as per Section 18(1) and 36(1) of the Legal Metrology Act, 2009 and Rule 6 of the Legal Metrology (Packaged Commodities) Rules, 2011.

5. Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible

Fine may extend to twenty-five thousand rupees. In case of second offence, fine may extend to fifty thousand rupees and thereafter it shall not be less than fifty thousand rupees but which may extend to one lakh rupees or with imprisonment for a term which may extend to one year or with both.

You are requested to kindly take the above information on record.
